Investment Objective and Strategy

The Target Fund also applies a sustainable strategy which aims to achieve a positive environmental and social impact by investing mainly in companies that benefit from global long-term themes resulting from secular changes in economic, social and environmental factors such as demographics, lifestyle or regulations. The Target Fund is the Pictet Global Thematic Opportunities Fund.

Outlook and Strategy

Equity valuations are looking more attractive. The market continues to underprice the persistence of secular growth. The strategy picks stocks with value drivers linked to megatrends, where it is believed that margins and sales growth will not fade. The strategy finds many of these investment opportunities in companies related to secular growth drivers in Personal Health & Wellbeing, Resource Efficiency, Connectivity, Industrial Efficiency and Digital Disruption.

Investment Policy / Prospective Investment

The Fund shall invest at least 90% of its assets in the Target Fund. The investment in the Target Fund shall not exceed 10% of the total net asset value of the Target Fund. The portion of the Fund that is not invested in the Target Fund, which shall not exceed 10% of the assets of the Fund, may be invested and/or reinvested in deposit products.

Related Party Transactions

The Fund currently has no investment with the Trustee's related parties.
